**NOTICE OF PUBLIC HEARING
PURSUANT TO NEW YORK GENERAL MUNICIPAL LAW §859-a
ON PROPOSED PROJECT AND FINANCIAL ASSISTANCE**

NOTICE IS HEREBY GIVEN that a public hearing pursuant to Section 859-a of the New York General Municipal Law will be held by the County of Lewis Industrial Development Agency (the “Agency”) on the 20th day of August 2020 in connection with the following matter:

Omni Navitas Holdings, LLC, a limited liability company(the “Company”) has submitted an application to the Agency requesting that the Agency consider undertaking a project at 9557 East Road (the “Project”) consisting of: (A) the installation, maintenance and operation of a solar array producing 2.25 megawatts AC of energy and transmission of such energy to an interconnection station; (B) the granting of certain financial assistance in the form of exemptions from real property taxes and sales tax (the “Financial Assistance”); and (C) the lease (or sub-lease) of the Land and the Facility by the Company (and/or the owner of the Land) to the Agency pursuant to a lease agreement; the acquisition by the Agency of an interest in the Equipment pursuant to a bill of sale from the Company; and the sublease of the Project Facility back to the Company (and/or the owner of the Land) pursuant to a sublease agreement.

The Company will be the operator of the Project Facility.

The Agency has not made a decision with respect to the undertaking of the Project or the granting of the Financial Assistance.

A hearing will be held in the town impacted by this project on August 20, 2020 at 4:00 pm local time, at the offices of the Town of Denmark, 3707 Roberts Road, Carthage,NY.

The Agency will at the above-stated time and place hear all persons with views in favor of or opposed to the Project and/or the Financial Assistance. A copy of the Company’s application including a cost/benefit analysis is available at the office of the Agency for review by interested persons.

Due to the COVID-19 outbreak the number of individuals allowed to enter the meeting room at one time will be restricted limited to 50% facility capacity, social distancing must be maintained, face masks are required. In addition, the facility will be cleaned and disinfected before and after the meeting.

Individuals desiring to submit comments are encouraged to submit comments in writing to the Office of the County of Lewis Industrial Development Agency in advance of the meeting at their address of 7840 State Route 26, PO Box 106, Lowville, NY 13367. Individuals who are not feeling well, who are showing symptoms of COVID-19, or who are members of a population particularly susceptible to COVID-19 should not attend the meeting.
